Sub:- Regarding observance of Malda Awaas Divas (2<sup>nd</sup> Phase) in connection with the additional quota of BAY 2020-21 (1<sup>st</sup> phase)

This is to inform you that there is an allocation of 43206 houses out of 55837 in 1<sup>st</sup> phase for Malda district under the programme BAY for the financial year 2020-21. The block wise target is given below:-

Now keeping in mind the timely as well as effective completion of houses, it is felt necessary that to observe "Malda Awas Divas" in all blocks on and from 27<sup>th</sup> May, 2020 to 1<sup>st</sup> June, 2020 involving above number of beneficiaries. Following activities are to be undertaken during the above noted period:-

1. Meeting and briefing with the beneficiaries and other stake holders at block level regarding details of the scheme like revised instalments structure, house patters, completion period (within 120 days after release of 1<sup>st</sup> instalments), use of logo etc.
2. On that day i.e on 2<sup>nd</sup> March 2020 all the beneficiaries will be handed over their entitlement cards.
3. All BAY beneficiaries will have to called in small batches in an open space. This time precautionary measures are to be taken during assemble of beneficiaries in view of outbreak of Covid-19. The practice of social distancing, washing hands with soap/sanitizer, use of face mask etc. Must be enforced in the meeting venue.
4. Block tagged senior officers SDOs, ADMs & DM will visit the block.
5. The process of construction of BAY houses and all aspects of the scheme will be explained to the beneficiaries.

Therefore all related activities like registration of beneficiaries, geo-tagging should be started immediately so that sanction can be given before observance of "Malda Awas Divas".


